



\$75 PRESEASON EQUIPMENT INSPECTION REBATE

Registered members of the BOSS Owners Group are eligible to receive a **\$75 rebate for each qualifying BOSS product inspected** during the **August 10, 2026–October 16, 2026** offer period. The rebate is valid on each qualifying BOSS product that is registered to the BOSS Owners Group member; and Is inspected by an authorized BOSS Snowplow Dealer during the offer period. Payment will be issued within 30 days of the 10/31 deadline.

Rebate limit: 12 qualifying units per member/company, for a maximum rebate of \$900.

IMPORTANT: Submissions for **6 or more units must include a completed W-9** at the time of submission.

⊗ QUALIFICATION DETAILS

1. The equipment inspection must be completed by an **authorized BOSS Snowplow Dealer**.
Find a dealer at bossplow.com/locator.
2. The equipment inspection must take place between **August 10, 2026 and October 16, 2026**.
3. You must be a registered member of the **BOSS Owners Group** and provide your valid BOSS Owners Group ID # on the rebate form. Your ID # can be found on your **My BOSS profile page**.
4. The inspected equipment must be registered to the BOSS Owners Group member.
5. A copy of the **inspection invoice showing the date of service and inspected equipment** must be submitted with the rebate form.
6. Only one rebate form is required per submission, even when submitting multiple qualifying units.
7. The rebate is limited to **12 units per member/company**.
8. **A completed W-9 is required for submissions of 6 or more units.**
9. Rebate submissions must be received by **October 31, 2026**.
10. Rebates received after the October 31, 2026 deadline will not be processed.
11. Rebate is valid in the **United States only**. Funds will be payable by check in U.S. currency.
